PLYMPTON MIXED USE DEVELOPMENT DR AMENDMENT FOR STAGE 2

RELEASE OF PROPOSED ALTERATIONS TO THE ORIGINAL (AND APPROVED) PROPOSAL

The Minister for Planning advises that proposed alterations to the original (and approved) proposal, pursuant to section 47 of the Development Act 1993 have been prepared by the Palmer Group.

The Palmer Group has applied to alter its Development Report to allow an amendment to the development of Stage 2 of the Plympton Mixed Use Development at Anzac Highway/Marion Road. Development of Stage 2 was previously for the basement car park, ground floor supermarket, ground floor retail, Commercial, and East Tower sixteen (16) two bedroom apartments and twentysix (26) serviced apartments. The amendment is for a reduction and reconfiguration of the retail area, an increase in supermarket area, deletion of the first floor commercial space, relocation of the basement car park to above the supermarket, deletion of serviced apartments adjacent the East Tower, increase in East Tower apartments to twenty-eight (28), and provision of basement storage for the supermarket.

An amendment to the Development Report (DR), pursuant to the Development Act 1993, has been prepared by Property & Consulting Australia to describe the changes to Stage 2 and to evaluate its potential environmental, social and economic effects.
