#### **Development Applications and Crown Developments**

SCAP considered three Development Applications and three Crown Developments in the reporting period, as outlined in the following tables.

Applicant	Summary	Resolved
Perry's Fuel Distributors	Railway Terrace, Yunta Self-serve retail fuel outlet including above ground fuel-cell (tank), canopy and advertising sign.	Approved.

Wesley Hurrell and Rita Hurrell	Range Road, Willow Creek Land division to create two additional allotments (one into three) within the Rural Zone and Limited Land Division Overlay.	Refuse to proceed to assess. The proposed development does not meet the intent of the State Planning Policies or desired outcomes for the Rural Zone.
Silver Walnut Pty Ltd C/- Cavallo Forest	Hay Flat Road, Normanville Land Division – one into 11 allotments (Torrens title) for residential purposes, reserve and road within the Rural Zone and Limited Land Division Overlay.	Refuse to proceed to assess. There is no reasonable prospect of a favourable assessment following consideration of the relevant Planning and Design Code policies.

Note: The Restricted Development application for Range Road, Willow Creek was assessed under the original Practice Direction 4 Restricted Development, while the Restricted Development application for Hay Flat Road, Normanville was assessed under Practice Direction 4 as revised in December 2022.
