3.1 Finalisation of the Character Preservation Acts Review

DISCUSSION

Anita Allen outlined the key recommendations of the review.

DECISION

The Commission notes the conclusions to the review and notes that as a consequence there will be no material change to the definition of the areas of the Act in the foreseeable future to the extent that minor and incidentals are proposed.

- 2. In light of Ministerial Correspondence dated 19th June 2018 the Commission will undertake a short term overview of the opportunities of additional and complimentary land uses within the areas, particularly related to economic activity.
- **3.** A Briefing is to be prepared by Anita Allen identifying an approach to the management of metro land settlement and opportunities for alternative approaches to manage growth and changes,

(particularly in Southern Adelaide) meeting the principles of urban renewal and consolidation of existing urban areas and accommodate long term housing and employment growth.
