	Communication activities have focussed on promoting the online and community drop-in sessions including boosted social media posts, providing information to local media outlets, and providing information to councils to assist in promoting community drop-in sessions in their local areas.
	As of 23 February, 51 submissions have been received. 2,700 people have visited the YourSAy website, with a total of about 4,000 visits and the draft Code Amendment document has been downloaded about 755 times.
Design Standards –	Engagement closed on 14 November.
Driveway Crossover Code Amendment	The engagement report is currently being prepared.
